Statement of Angelique Stubblefield

I attended USC from 1989 to 1994. I sought medical assistance from the USC Health Center in the fall of 1989 for a very basic yeast infection. While there, I was examined by Dr. George Tyndall who gave me a pelvic examination.

During my visit, he examined me unattended and indicated that I had a "tilted cervix" and asked to photograph my vagina for his research. Since I had never seen a gynecologist prior to Dr. Tyndall, I acquiesced and agreed thinking I was helping the university in its medical studies.

For years I have been affected by this visit. For many years after Dr. Tyndall examined me, I told people that I was diagnosed with a tilted cervix. I found out years later by visiting another gynecologist that this was not true.

Then, On May 16, 2018, after reading the Los Angeles Times article about Dr. Tyndall's inappropriate conduct, I experienced an extreme spike in my blood pressure and was transported to an ER hospital facility from my place of employment for an emergency hypertensive episode. My blood pressure was documented at 236/130 and I have remained on high blood pressure medication since. I have missed weeks of work and have been left confused, depressed and anxiety ridden. As a result, I am currently seeking therapy! I didn't even know how to speak to my children about the issue.

This has been very traumatizing for me as I have had to relive this horrible experience all over again every day since May 16th, 2018 after hibernating the experience in the back of my mind for decades. This happened almost 30 years ago! Public awareness of his decades of abuse is confirmation of not only my experience but the hundreds of other victims of his sadistic abuse!

I hold not only Dr. Tyndall accountable for his sick, sexual predatory actions, but I want USC to be held accountable for having knowledge of this abuse and turning a blind eye to Dr. Tyndall's actions and his victims!

I am utterly appalled by how his perverse behavior has been handled by this University! I was so incredibly proud to be accepted and to attend what I thought was a prestigious

academic institution that cultivated talented minds seeking the common goal of educating our youth to be the next generation of leaders.

It is now my perception that USC takes care of their own staff and faculty and it is also my perception that they run a business and not an elite academic institution as I once believed as an innocent 18 year old entering this university.

Dr. Tyndall and USC have stripped the confidence and trust of hundreds of students who sought medical treatment under Dr. Tyndall's care. It is NOW time to make it right and start the healing process! My incident happened back in 1989! What if the University acted upon the first complaints decades ago? Take a moment to contemplate that! Where would we be today?

I am someone's daughter, I am someone's mother! I put my trust in an academic institution to take reasonable care and provide a certain amount of prudent protection while attending college.

This clearly this should not have happened to me or the alleged hundreds of young women who sought treatment at what should have been the safest place on campus! I am just asking for the University to make this right and perhaps give not only myself, but these other women justice for the horrific experiences we have endured! Thank you!
